

#### Privacy Policy:

Fallon Builders Limited (“Fallon”) operates fallon.builders and may operate other websites. It is Fallon’s policy to respect your privacy regarding any information we may collect while operating our websites.

#### Website Visitors

Like most website operators, Fallon collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Fallon’s purpose in collecting non-personally identifying information is to better understand how Fallon’s visitors use its website. From time to time, Fallon may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Fallon also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on fallon.builders. Fallon only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

#### Gathering of Personally-Identifying Information

Certain visitors to Fallon’s websites choose to interact with Fallon in ways that require Fallon to gather personally-identifying information. The amount and type of information that Fallon gathers depends on the nature of the interaction. For example, we ask visitors who sign up at Fallon to provide a username and email address. Those who engage in transactions with Fallon are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Fallon collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor’s interaction with Fallon. Fallon does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

#### Aggregated Statistics

Fallon may collect statistics about the behavior of visitors to its websites. Fallon may display this information publicly or provide it to others. However, Fallon does not disclose personally-identifying information other than as described below.

#### Protection of Certain Personally-Identifying Information

Fallon discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organisations that (i) need to know that information in order to process it on Fallon’s behalf or to provide services available at Fallon’s websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organisations may be located outside of your home country; by using Fallon’s websites, you consent to the transfer of such information to them. Fallon will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organisations, as described above, Fallon discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Fallon believes in good faith that disclosure is reasonably necessary to protect the property or rights of Fallon, third parties or the public at large. If you are a registered user of an Fallon website and have supplied your email address, Fallon may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what’s going on with Fallon and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Fallon takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

#### Cookies

A cookie is a string of information that a website stores on a visitor’s computer, and that the visitor’s browser provides to the website each time the visitor returns. Fallon uses cookies to help Fallon identify and track visitors, their usage of Fallon website, and their website access preferences. Fallon visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Fallon’s websites, with the drawback that certain features of Fallon’s websites may not function properly without the aid of cookies.

#### Business Transfers

If Fallon, or substantially all of its assets, were acquired, or in the unlikely event that Fallon goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Fallon may continue to use your personal information as set forth in this policy.

#### Ads

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognise your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Fallon and does not cover the use of cookies by any advertisers.

#### Privacy Policy Changes
